"10. Voting on Master Association Matters. The Association is entitled to one (1) representative on the Board of Governors of the Master Association, which representative shall be entitled to cast all votes of the members of the Association in the affairs of the master Association. The representative shall have as many votes in Master Association matters as the number of parcels in the Community. All such votes shall be cast in a block. Not later than March 15th of each year in which a regular vacancy will occur to the Community, the Board of Directors shall designate in writing one (1) natural person who shall serve as a Governor of the Master Association from the annual organizational meeting of the Board of Governors until the annual organizational meeting at which his/her three (3) year term shall expire, or until his earlier death, resignation, removal or temporary inability to serve due to illness or absence from the Naples area or because of a personal conflict.. Any vacancy occurring in the office (whether temporary or permanent) for any of the aforementioned reasons shall be filled by the Board of Directors so that The Preserve Association, Inc. shall always have a representative present for meetings of the Wyndemere Homeowners Association, Inc., Board of Governors. Notice of such change of Governor will be given in writing to Wyndemere Homeowners Association. Such notice shall be signed by an officer of The Preserve Association, Inc."
