10. Games and Play Structures. All basketball backboards, tennis courts, <u>putting greens</u> and play structures shall be located at the rear of the dwelling, or on the inside portion of corner Lots within the setback lines <u>and will conform to all Collier County Ordinances and Building Codes</u>.
