AMENDMENTS TO THE AMENDED AND RESTATED BYLAWS OF EDGEWOOD ASSOCIATION, INC.

The Amended and Restated Bylaws of Edgewood Association, Inc. shall be amended as shown below:

Note: New language is underlined; language being deleted is shown in struck through type.

Section 6. of the Bylaws shall be amended to read as shown below:

MASTER ASSOCIATION REPRESENTATION. The Association is entitled to one (1) 6. representative on the Board of Governors of the Master Association, which representative shall be entitled to cast all votes of the members of the Association in the affairs of the Master Association. The representative shall have as many votes in Master Association matters as the number of parcels in the Community. All such votes shall be cast in a block. The Board of Directors of the Association shall designate in writing. The Association shall elect at the annual meeting of the Association, from nominations from the floor one (1) natural person who shall serve as a Governor of the Master Association from the next annual organizational meeting of the Board of Governors until the organizational meeting at which his Successor takes office, or until his earlier death, resignation or removal. The term of office shall be three (3) years unless otherwise provided in the Master Association Governing Documents Declaration. Any vacancy occurring in the office shall be filled by the Board of Directors of the Association. Any representative may be removed with or without cause by the Board of Directors of the Association. The representative shall be a member of the Association and may be the President or other officer or director thereof. A representative who is not a director shall serve as an ex-officio member of the Association's Board of Directors.
